Application Requirements

The following is needed along with the application:

1. \$110.00 per individual for the criminal history background
2. two 1" x 1" photos (passport size)
3. 1 form of picture ID (driver's license, passport, etc.)
4. Written permission or a lease provided signed and notarized by the owner of the land whereon the place of business is established authorizing the person to establish the place of business.
5. If temporary structures (ex: tents) are to be set up, contact Butler Twp. Zoning at (724) 287-7465.

Fees

After Approval there will be License Fees of:

- \$ 60.00 per day
- \$ 250.00 per week
- \$ 1,200.00 for 6 months
- \$ 2,000.00 annual

This fee includes 1 solicitor badge to be visible at all times.

A \$25.00 fee will be added for each additional badge.
